AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF TATUM, TEXAS, AND CREATING AN EMERGENCY.

BE IT KNOWN that it has been certified to the satisfaction of the City Council of the City of Tatum, that a majority of the qualified voters in the territory hereinafter described has certified their desire to become annexed to the City of Tatum, Texas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TATUM, TEXAS, that the following described property and territory, to-wit:

Being situated in the John Tomlinson Survey of Panola County, Texas, and in the John Tomlinson, J. Corbett and John Webster Surveys of Rusk County, Texas, and described as follows:

BEGINNING at a point in the present City Limit line 1411.5' N. 88 deg. 25' W. from West ROW line of R.R. said point being in the North City Limit line,

THENCE NORTH 1 deg. 35' East 2075.0' point for corner, THENCE North 89 deg. 07' West 4550' to point for corner, THENCE South 1 deg. 00' West 12,478' to point for corner,

THENCE North 84 deg. 40' East 7,164.50' point for corner,

THENCE North 5 deg. 20' W. 2640' to point in present City Limit, Said point being in West ROW line of R.R. and same being in South City Limit Line,

THENCE South 84 deg. 40' W. with present City Line 4194' to S.W. corner, present City limits,

THENCE North 1 deg. 00' East with present City Limits 8130' to present N.W. Corner City Limits,

THENCE South 89 deg. 07' East with present City Limits 1377.70' to corner present City Limits,

THENCE South 0 deg. 25' West with City Limits, 249.4' to present Corner,

THENCE South 23 deg. 00' East 459' to Corner present City Limits,

THENCE South 88 deg. 25' East with present City Limits 300' to place of beginning, containing 108.5 acres, more or less,

be and hereby is annexed to and made a part of the City of Tatum, Texas henceforth.

All Ordinances of the City of Tatum, Texas, or provisions thereof,

in conflict with this Ordinance, are hereby repealed.

The fact that such territory is not presently annexed to the City of Tatum, Texas and does not have the benefit for its inhabitants of the conveniences afforded other members of the City of Tatum at the present time, creates and constitutes an emergency requiring that the provision that an Ordinance be read at three several meetings before passage be suspended, and this Ordinance shall become effective immediately upon its passage, signature of the Mayor and publication.
