Dear Representative Hopson:

I am writing to request that you support legislation in the 2003 Legislature to delay the implementation of electric deregulation in the SWEPCO service territory in northeast Texas. A coalition of over 20 cities (i.e. Cities Advocating Reasonable Deregulation CARD) in the East Texas region served by SWEPCO has renewed their efforts to delay electric deregulation. Previously we had contacted you in asking for your assistance in getting some type of relief from the premature implementation of electric deregulation and are grateful of your supportive role. Retail electric choice must be postponed until there is proof that families, businesses, economic development, and the local economy will not be harmed by rising electric costs.

Deregulation has been delayed for the Panhandle are of Texas, and citizens in East Texas deserve the same protection. The pilot project in our area was a flop – not a single customer participated— so it should be clear that now nor in the near future is the time for full-fledged electric deregulation.

Arkansas and Oklahoma have delayed electric deregulation in the area served by SWEPCO, and Texas should do the same. Otherwise, we'll be at a competitive disadvantage when competing for new businesses and industries. Louisiana has not even passed a deregulation law. The PUC recognized that real problems exist and recommended a delay in the deregulation in our region.

Please support our legislative efforts to postpone electric deregulation in the SWEPCO area in the 2003 Legislative Session.
